#### Trading Places: An Interactive and Hands-on Session Where You as The Advocate/Attendee Will Conduct The Accident Reconstruction and The Biomechanical Analysis in an Incident Resulting in Brain Injury

This session will be led and overseen by an Accident Reconstruction Engineer, a Biomechanical Engineer, a Private Investigator, a Police Officer, a Courtroom-Visualization and Imaging Specialist, a Physician and a Former Judge.

As the incident itself unfolds before your eyes, you will be permitted to question the "players" involved in the incident itself... Similarly, you will analyze the biomechanics of the incident, an injury side by side with the bottom mechanical engineers. You will then – in a step-by-step fashion, assess and evaluate causation and all aspects of damages.

Weeks prior to this seminar event, each attendee will be provided with a complete "package" regarding this session, as it will be advisable and necessary to do some level of preparation if in fact, you want to maximize the value you will obtain from this session. 
